LOCATION

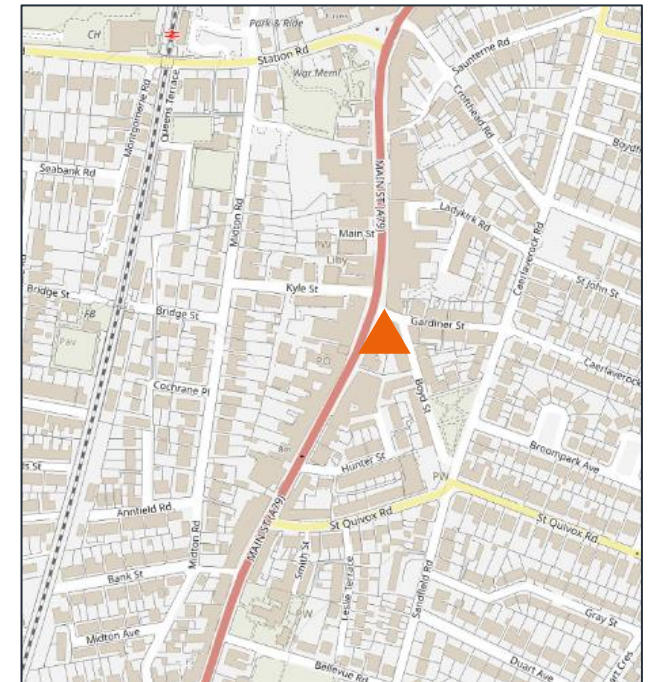
