LOCATION

The subjects are situated in the residential area of Mount Vernon which is located in the east end of Glasgow. The area was originally a mining village but has seen significant change over the years.

Mount Vernon is well-connected to Glasgow through various methods such as bus and train. The nearby Mount Vernon train station provides access to Glasgow City Centre and other surround areas nearby.

DESCRIPTION

The total site area extends to approximately 1.53 hectares (3.79 acres). The subjects exclude the area shaded in pink on the title plan overleaf. Please refer to the legal pack for further information.

The subjects comprise an irregular shaped site that runs under the B7058. Entry to the site is gained from the nearby access road, and the configuration of the site would lend itself towards a variety of uses subject to planning. The site is covered in a mixture of vegetation and woodland.

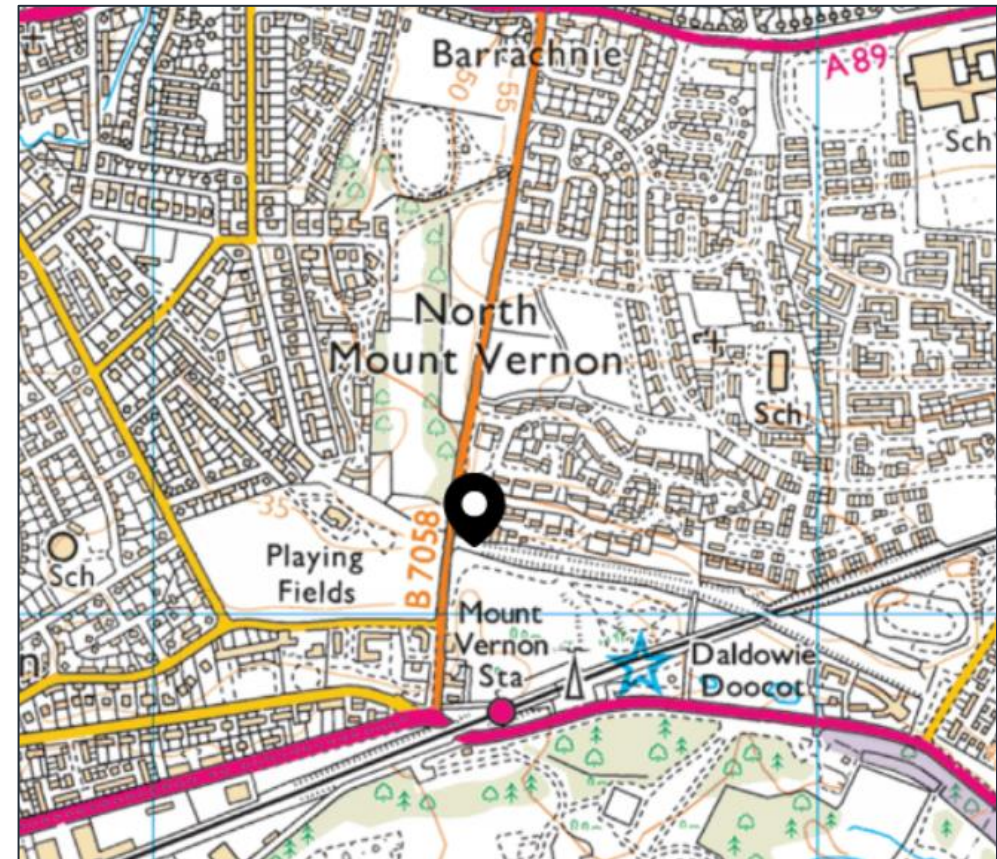
PLANNING

LAND AT MOUNT VERNON, GLASGOW

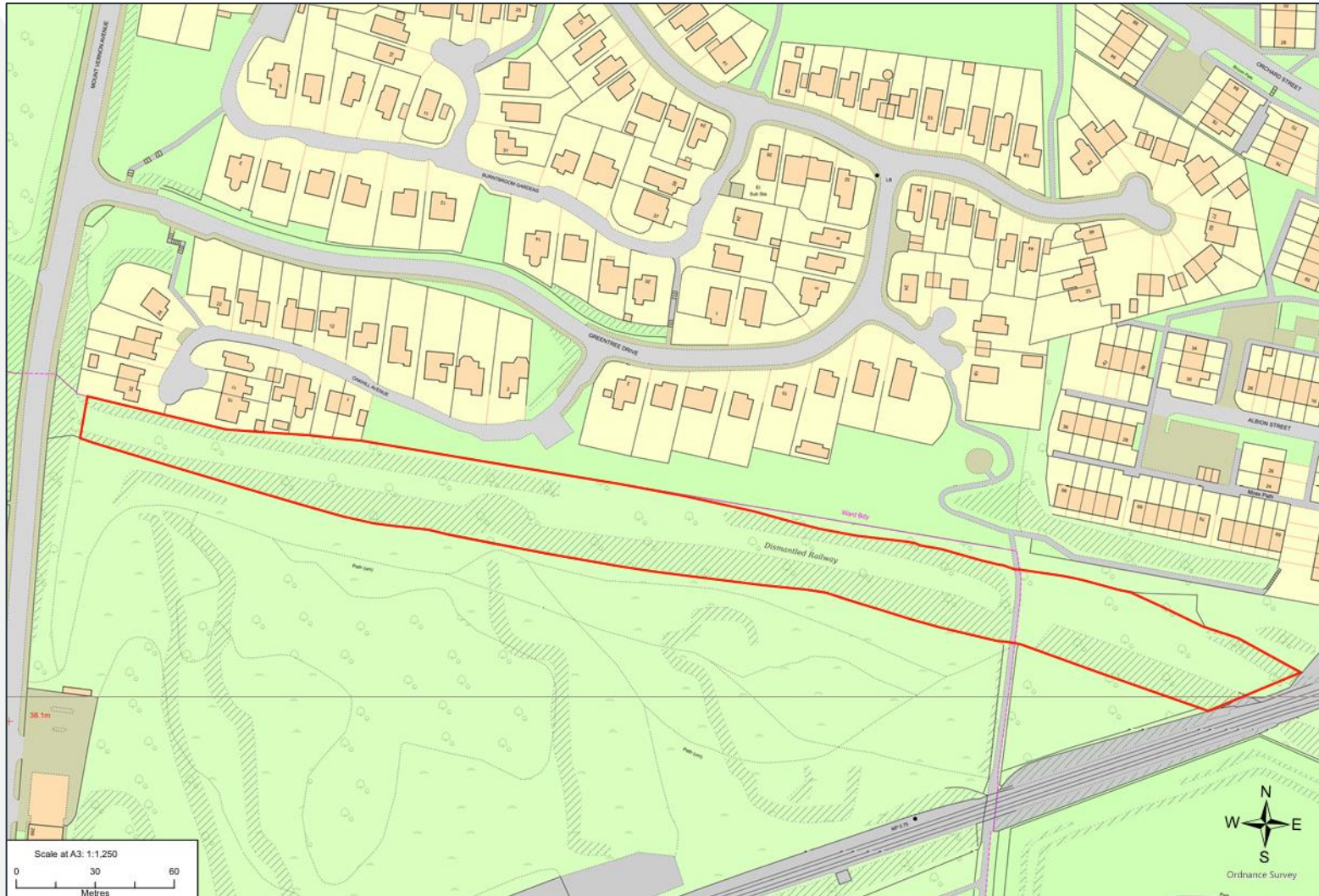
