There is a small area of yard and car parking surrounding the subjects.

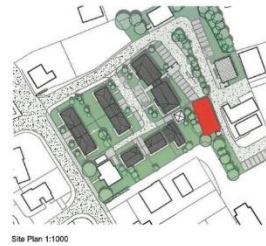
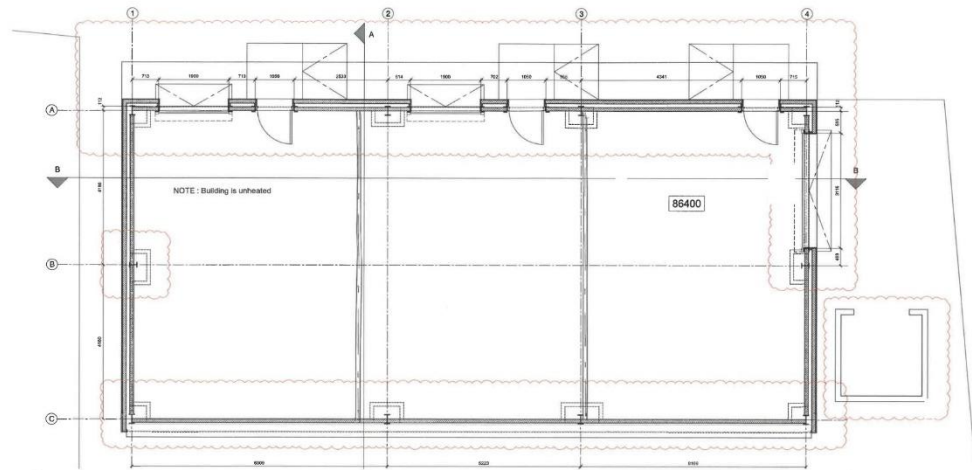
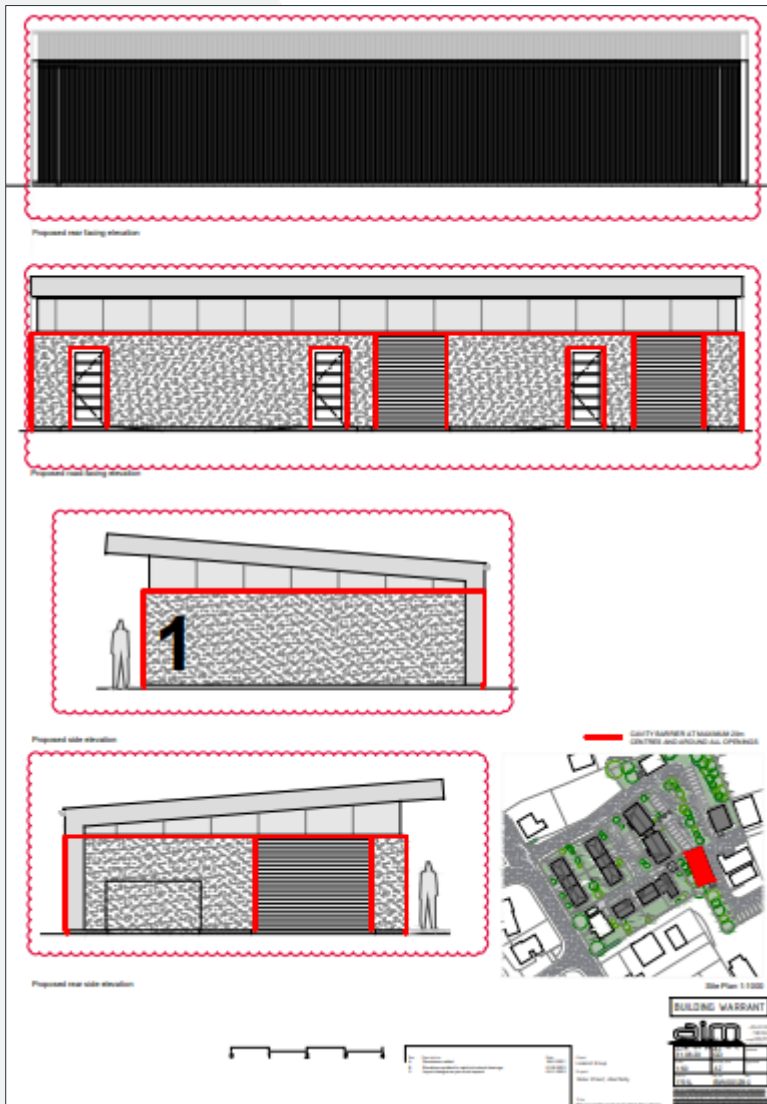
